Dear Kelly:

You were appointed to the Neighborhood Advisory Committee (NAC) for the Golden Gate Neighborhood Community Redevelopment Area by the Martin County Board of County Commissioners on 9/11/2017. I realize that due to demanding personal and business schedules, it is sometimes difficult to attend the NAC meetings and I note that you have missed two scheduled meetings. Unfortunately, based on the attendance requirements, this puts you in jeopardy of losing your seat on the NAC. The Board of County Commissioners will actively seek a replacement upon the occurrence of the third meeting that you miss.

The attendance requirement is outlined in the Martin County Code of Ordinances in Section 39.4.A.b: "*All members appointed by the board to serve on neighborhood advisory committees are expected to attend each and every meeting of the committee. If a member is absent from three meetings of the committee within a twelve-month period (twelve months beginning from the committee member's start date), said member is automatically removed from the neighborhood advisory committee, but may apply for re-appointment by the Board of County Commissioners.*" I hope that you concur that it is essential that the NACs meet as a complete body, as their work will guide the future of our neighborhoods.

I do hope that you can continue to serve on the NAC. Your community needs input from its citizens and your role is extremely important to successful redevelopment. Please feel free to call me if you need to review the meeting schedule or if you determine that it is too difficult for you to serve on the NAC.
