Re: Time Extension for Resubmittal of Required Documents

Dear Mr. Wichser:

Section 10.2.D.4, Land Development Regulations (LDR), Martin County Code states that the applicant shall have ninety (90) days from the issuance date of the report to resubmit. The County Administrator may grant one (1) extension not to exceed sixty (60) days upon a showing of good cause.

Please be advised that your request for a 60 day time extension to resubmit the required documents, dated March 6, 2019, for the Locks Estates Plat and Revised Final Site Plan application is hereby granted. With this approval, the timetable to resubmit required documents is extended from March 21, 2019 to May 20, 2019.

The authority for the administrative extension of the time to resubmit the required documents is provided in Section 10.2.D.4, Land Development Regulations (LDR), Martin County Code. Please be advised that the maximum time extension that is provided by law is 60 days, and no further time extensions can be authorized beyond that period.
